Hellenic DanceSport (“we,” “us,” or “our”) is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your personal information when you visit our website <http://hellenicdancesport.com> (the “Site”) and participate in our activities, competitions, or memberships.

### 1. Information We Collect

We may collect personal information that you voluntarily provide to us when you register for events, sign up for a membership, or contact us. This may include:

- **Identity Data:** Name, date of birth, gender, and nationality (required for athlete registration and age-group categorization).
- **Contact Data:** Email address, phone number, and mailing address.
- **Performance Data:** Competition results, rankings, and dance club affiliations.
- **Multimedia:** Photos and videos taken during sanctioned events (used for promotion and results).
- **Technical Data:** IP address, browser type, and usage patterns collected via cookies.

### 2. How We Use Your Information

We process your data for the following purposes:

- **Event Management:** To process registrations, manage competition brackets, and publish results.
- **Communication:** To send updates regarding events, rule changes, and organizational news.
- **Legal Compliance:** To comply with the requirements of the World DanceSport Federation (WDSF) or Greek national sports laws.
- **Promotion:** To showcase the sport through photography and videography on our website and social media.

### 3. Legal Basis for Processing (GDPR)

Under the GDPR, we process your data based on:

- **Contractual Necessity:** To fulfill our obligations for memberships or event registrations.
- **Legitimate Interest:** To maintain the integrity of competitive dance rankings and promote the sport.
- **Consent:** Where you have explicitly opted in (e.g., for marketing newsletters).

### 4. Sharing Your Information

We do not sell your data. We may share information with:

- **Affiliated Bodies:** Such as the WDSF, local dance clubs, or national sports authorities.

- **Service Providers:** Third-party vendors who assist with website hosting, payment processing, or competition management software.
- **Legal Authorities:** If required by law or to protect our legal rights.

## 5. Data Retention

We retain personal data only for as long as necessary to fulfill the purposes for which it was collected, including for the purposes of satisfying any legal, accounting, or reporting requirements (e.g., historical competition results).

## 6. Your Rights

If you are a resident of the European Economic Area (EEA), you have the following rights:

- **Access:** The right to request copies of your personal data.
- **Rectification:** The right to request that we correct inaccurate information.
- **Erasure:** The right to request that we delete your data (subject to legal retention requirements).
- **Restriction:** The right to request that we limit the processing of your data.
- **Data Portability:** The right to receive your data in a structured, machine-readable format.
